

7TH STREET KIDS 2021 MUSICAL THEATRE WORKSHOPS ** AUDITION REGISTRATION FORM

7TH STREET KIDS IS PLEASED TO OFFER TWO (2) MUSICAL THEATRE WORKSHOPS FOR SUMMER 2021. Each workshop will feature performance of a favorite Disney show and be the highlight of the summer for both our participants and audiences!

The workshops will be held in-person, in the 7th Street Theatre in Hoquiam. Children must be age 7-16 as of June 15, 2021 to participate. In addition, due to COVID-19, former 7th St Kids who will be 17 years old on June 15th will also be allowed to audition this year.

"FROZEN JR" WORKSHOP AND PERFORMANCE ~ June 17-August 1 (no rehearsal July 5th). The workshop and rehearsals will be held Monday thru Friday from 9 AM-1 PM, with night time rehearsals and performances the final week, and a matinee on Sunday, Aug. 1st.

"WINNIE THE POOH KIDS" WORKSHOP AND PERFORMANCE ~ June 28- July 17 (no rehearsal July 5th). The workshop and rehearsals will be held Monday thru Friday from 2-4 PM, with one evening performance on July 16th and a matinee on July 17th.

AUDITION SCHEDULE:

- 1) Auditions will held JUNE 5th at the 7TH STREET THEATRE in Hoquiam.
- 2) An AUDITION APPOINTMENT will be scheduled for you after all registration forms have been received.
- 3) Each audition appointment will be limited to five (5) participants, and will last 45 minutes to 1 hour.

DEADLINE FOR SUBMITTING THIS AUDITION REGISTRATION FORM IS MAY 28, 2021 to guarantee an audition appointment on June 5th. If this form is received after the deadline, your child is not guaranteed an audition spot.

TUITION for the Frozen JR workshop is \$250; and \$125 for the Winnie The Pooh KIDS workshop. Tuition is due by midnight June 30, 2021. Scholarships are available, and application may be requested after the Frozen JR and Winnie The Pooh KIDS casts have been announced.

Due to the continuing COVID-19 pandemic, 7th Street Kids is following CDC and State guidelines for live theatre and performing arts activities, and has adopted Covid-19 protocols including sanitation practices, social distancing, and use of masks. WE ARE ALSO LIMITING PARTICIPATION TO NO MORE THAN 20 CHILDREN PER WORKSHOP. This will allow us to provide an exceptional musical theatre training and performance experience for your child while following our COVID-19 safety plan.
